THE DAY PROGRAM CLOSED IN MARCH OF 2020 AND RESUMED OPERATIONS BEGINNING IN JULY 2020. THE DAY PROGRAM RAN AT ABOUT 25-30% CAPACITY FROM JULY 2020 THROUGH JUNE 2021. IT SHOULD ALSO BE NOTED THAT BOTH PROGRAMS CLOSED FROM 12/5/20 THROUGH 1/25/21 OTHER THAN SOME IN-HOME SERVICES PROVIDED.
